This is a funeral where family and friends have a ceremony, event or service for the deceased person at the same time as they attend their burial or cremation.	
Taking care of all necessary legal and administrative arrangements	£ 2,110.00
Collecting and transporting the deceased person from the place of death (normally within 20 miles of the funeral director's premises) into the funeral director's care	£ 325.00
Care of the deceased person before the funeral in appropriate facilities. The deceased person will be kept at our premises until the day of the funeral:	£ 245.00
Providing a suitable coffin – this will be made from [Oak Veneer with linings and fittings suitable for cremation]	£ 545.00
Viewing of the deceased person for family and friends, by appointment with the funeral director (where viewing is requested by the customer)	£ 30.00
At a date and time you agree with the funeral director, taking the deceased person direct to the agreed cemetery or crematorium (normally within 20 miles of the funeral director's premises) in a hearse or other appropriate vehicle	£ 630.00
UNATTENDED FUNERAL	
This is a funeral where family and friends may choose to have a ceremony, event or service for the deceased person, but they do not attend the burial or cremation itself.
